Besides, MCI is entitled to take all such measures against you and your college/institution as permissible under the law.

The college shall not admit more than one batch of students against this letter of permission. The college shall also apply to Medical Council of India for renewal of permission well before the commencement of next academic session. While applying for such renewal, the achievements in terms of infrastructure, staff and equipments as spelt out in the time bound action plan and as per the norms by Medical Council of India, must be clearly indicated. The next batch of students shall not be admitted unless renewal of permission is granted by the Board of Governors, Medical Council of India/Central Government.

This permission is subject to furnishing of undertaking to the effect by the State Govt. that the Govt. shall provide funds in their plan budget regularly till the requisite facilities are fully provided as per the time bound programme for the establishment of new medical college and hospital found to be adequate / genuine on all counts. The admission process for the academic year 2011-12 has to be completed in accordance with the time schedule indicated in the Graduate Medical Education Regulation, 1997, as amended.

The compliance verification assessment report (21st February, 2017) along with the previous assessment reports (19th July, 2016 4th May, 2016 and 14th & 15th March, 2016) was considered by the Executive Committee and subsequently by the General Body of this Council at its meeting held on 29.03.2017 The Council approved the following recommendations of the Executive Committee:-

"The Council noted that thecompliance verification assessment report(21st February, 2017) alongwith previous assessment report (19th July, 2016 4th May, 2016 and 14th & 15th March, 2016) with regard to recognition/approval of Malda Medical College & Hospital, Malda for the award of MBBS degree (100 seats) granted by West Bengal University of Health Sciences, Kolkata, West Bengal u/s 11(2) of the IMC Act, 1956 was considered by the Executive Committee of the Council at its meeting held on 16/03/2017 and it was decided as under:-

"The Executive Committee of the Council considered the compliance verification assessment report (21st February, 2017) along with previous assessment reports (19th July, 2016, 4th May, 2016 & 14th /15th March,2016) and decided to recommend to the Central Government for recognition/approval of Malda Medical College & Hospital, Malda for the award of MBBS degree (100 seats) granted by West Bengal University of Health Sciences, Kolkata, West Dengal u/s 11(2) of the IMC Act, 1956.

The Executive Committee further decided that the attention of the institute be drawn to Sections 8(3)(2), 8(3)(3) & 8(3)(4) of the Establishment of Medical Colleges Regulations (Amendment), 2010 (Part II) dated 16th April 2010 and act accordingly at appropriate time, which reads as under:-8 (3) ...

- (2) The recognition so granted to an Undergraduate Course for award of MBBS degree shall be for a maximum period of 5 years, upon which it shall have to be renewed.
- (3) The procedure for 'Renewal' of recognition shall be same as applicable for the award of recognition.
- (4) Failure to seek timely renewal of recognition as required in sub-clause (a) supra shall invariably result in stoppage of admissions to the concerned Undergraduate Course of MBRS at the said institute...."
